RESOLUTION AUTHORIZING AN AGREEMENT FOR EMPLOYMENT OF AN EXECUTIVE DIRECTOR

WHEREAS, the Housing Authority of the Town of West New York, in the County of Hudson (the "Housing Authority") is a public body corporate and politic, constituting an agency and instrumentality of the Town of West New York, County of Hudson, State of New Jersey, created pursuant to the provisions of the Housing Authorities Law, Chapter 67 of the Pamphlet Laws of 1950, codified at N.J.S.A. 55:14A-1 <u>et seq.</u>, repealed and replaced by the Local Redevelopment and Housing Law, under Chapter 79 of the Pamphlet Laws of 1992, as amended and supplemented, and codified at N.J.S.A. 40A:12A-1 <u>et seq.</u> (the "Act"); and

WHEREAS, pursuant to <u>N.J.S.A.</u> 40A-12A-18, and as approved by the New Jersey Department of Community Affairs, Division of Housing and Community

Resources, the Housing Authority has had a renewing five (5) year employment agreement with its Executive Director, Robert A. DiVincent since October 14, 1999; and
