### MINUTES SCHEDULED CAUCUS MEETING -NOVEMBER 23, 2015

Minutes of Scheduled Caucus Meetings of the Board of Commissioners of the Housing Authority of the Town of West New York, in the County of Hudson, State of New Jersey held in the office of the Housing Authority at 6100 Adams Street,
West New York, New Jersey 07093 on December 15, 2014.

Secretary Robert DiVincent called the scheduled meeting to order at 7:30 p.m.

All Commissioners were present with the exception of Commissioner Perez.

Mr. DiVincent referred to item #3 – Minutes of previous scheduled regular meeting dated October 19, 2015 asking if there were any corrections, additions, comments or questions. There were none.

Mr. DiVincent then referred to items #4 through #6 – Claims–General Fund Program, Capital Fund Program and Section 8/WTW Program, asking if there were any corrections, additions, comments or questions. There were none.

With regard to Item # 7- New Business - the following resolutions were brought before the Board:

Resolution No. 2015–045 Fiscal Year 2015-2016 – Flat Rent Policy. Mr. DiVincent explained to the board how the Housing Authority charges 30% across the board to all tenants but there are situations where the tenant qualify when they move in but after a few years their entire household income goes up, then the tenant pays more than 30% and at this point the Housing Authority offered them the choice of 30% or the flat rent which is 85% of what their apartment will pay anywhere else in this area.

Resolution No. 2015-046 Three years Union Contract, October 1, 2014 to September 30, 2017. Mr. DiVincent explain to the board that the employees will received 3% or \$1,250.00 whichever is greater, also changes were made with regards to asking for vacations. Employees no longer could call in vacation days, if taking only one day they need to be requested 48 hours prior, if taking two weeks they need to be requested two weeks prior. Also the board was informed that the office staff will be using uniforms (black, grey or navy blue) slacks with a blue shirt and a name tag. Commissioner Roque question about the shoes and Mr. DiVincent explain that the Housing Authority will be paying for 5 blouses and that the employees are responsible for the rest.

Resolution No. 2015-047 Settlement Agreement of Ricardo Saez- At this time Mr. DiVincent explain to the board that Ricardo Saez has agreed to the One Strike you're Out Policy. Vice-Chairperson Roque expressed her concerns about the situation, she agreed to go along with the board but insisted that Mr. DiVincent must monitor the situation and report back to the board in a monthly basic. Mr. Divincent informed the board that Ricardo Saez will be working in the boiler rooms and will be supervise at all time by himself and other two employees. Also the board was informed that Ricardo Saez didn't get protected at all and was suspended for 6 months.

At this time Mr. DiVincent reminded the board that the Housing Authority is moving forward with the RAD Program and the PCA has been completed. Mr. DiVincent explaind that PCA came back twice more than he thought (50 million dollars) but the Housing Authority doesn't have the borough capacity for that amount, borough capacity is between 20 and 24 million dollars only. Mr. DiVincent also explained to the board that the program has 3 options which are to do one end, the other end or all the Housing Authority which he prefers.

At this time Mr. DiVincent reminded the board of the annual Christmas Party which will be held December 18, 2015 at 7:00 pm at Marinero Grill.

At this time Vice-Chair Roque made a motion to adjourn and Commissioner Fuentes seconded.
