TITLE

This resolution shall be known and may be cited as the Cooperative Pricing Resolution of the West New York Housing Authority

Authority

Pursuant to the provisions of N.J.S.A. 40A:11-11(5), the Executive Director is hereby authorized to enter into a Cooperative Pricing Agreement with the Lead Agency.

Contracting unit

The Lead Agency shall be responsible for complying with the provisions of the local public contracts law (N.J.S.A. 40A:11-1 et seq.) and all other provisions of the revised statutes of the State of New Jersey.

Effective Date

This resolution shall take effect immediately upon passage.
